Medical/Health Conditions

- I confirm that I am physically fit and able to participate in the activities and I have not been advised otherwise by a qualified medical person.
- I consent to receive any medical treatment that may be deemed necessary by E-KO New Zealand Limited in the event of injury, accident or illness while undertaking these activities
- I understand that it is my responsibility to disclose any conditions (health or otherwise) that may affect the safety and enjoyment of myself and those around me.

Drugs/Alcohol

I confirm that I am not under the influence if intoxicating drugs or alcohol (be they legal
or illegal) which may in any way impair my ability to undertake the activity

Conditions of Participating in this Activity

- I agree to wear the appropriate provided equipment and use/wear all safety clothing and equipment (as required by the guide) when participating in this activity.



Limited liability of E-KO New Zealand Limited

- I understand that if I act recklessly or intentionally, and do not follow the rules or
 instructions set out by the guide, and which I have been made aware of, E-KO New
 Zealand Limited will not be held responsible for any injury, damage, or loss I cause to
 myself/my property,
- I release or indemnify E-ko New Zealand Limited and their staff against any liability incurred to anyone else, resulting from my failure, or the failure of any person accompanying me under the age of 18, to follow their instructions.
- I agree that to the extent permitted by law: All liability to any damage to my property, disruption to my travel plans, or mental injury is excluded.
